## CIRCULAR

Sub: Regarding Conducting Classes in Hybrid Mode for Students up to Class IX and XI.

The Commission for Air Quality Management in National Capital Region and Adjoining Areas in its order No. 120017/27/GRAP/2021/CAQM dated 13.12.2025 (copy enclosed) has stated that:

"Accordingly, in an effort to prevent further deterioration of the air quality, the Sub Committee on GRAP hereby decide to invoke all actions under Stage-IV ('Severe+' AQI of Delhi >450) of extant schedule of GRAP (read with paras 6, 7 & 8 below), with immediate effect in right earnest by all the agencies concerned in Delhi-NCR, in addition to the Stage-I, II and III actions already in force."

In compliance of the above order, all Heads of Schools of Government, Government Aided, Unaided Recognized Private Schools of DOE, NDMC, MCD and Delhi Cantonment Board are directed to conduct classes in schools for children up to Class IX and XI in a "Hybrid" Mode i.e. both in physical and online mode (wherever online mode is feasible) with immediate effect until further orders.

The option to exercise the online mode of education, wherever available, shall vest with the students and their quardians.

Further, all Heads of Schools are directed to disseminate this information to the parents and guardians of the students immediately.

All DDE (Zone/ Districts) are also requested to visit schools under their jurisdiction to ensure smooth compliance of the above directions.
